Providing a response for the Commissioner since I know you need to get back to her:

The Ocean Ave project will not cover platform extensions on the corridor. SFMTA is seeking funding for a Muni Forward planning/design/implementation for the K line. This would include outreach on extended platforms, and planning for/implementation of these if the community supports them. Please note that the community will be faced with trade-off discussions related to extending platforms to accommodate two-car trains: in many locations, implementing these would require on-street parking removal.
