If the cross-reference field track changes are distracting, please take the following steps: (1) turn off track changes, (2) select all (ctrl+a), (3) press F9. Taking these steps will clear up the cross-referenced fields. Turn track changes back on and you can continue with edits. Hopefully this eases your review a bit.
