I'm still hopeful that you will reply to my email in light of your offer of a phone conversation. I have a few more questions to add.

I see now that the position of North St. was considered in the SEIR under something called Variant 4.

Could you please forward a link to the pedestrian counts for the crossings at Cloud Circle used in evaluation of Variant 4? Also, the motorcycle parking usage Data on the East side of Frida Kahlo. Especially the usage during peak travel times anticipated by the new development residents. Please forward that as well.

Also, pedestrian circulation studies through the City College parking lot?

The RTC document shows that Variant 4 might be considered as mitigation for the complaints received during the EIR about construction traffic.

How early in the construction schedule would this occur?

Would a signal be installed during the construction phase?

The new road could be situated 400° from the MUB and presumably closer to the parking entrance currently used by City College to that lot, which includes variable traffic there at the MUB. Could you please point me to the documents outlining the interface between the two, especially during the construction of the road change?

Thank you for your offer to speak on the phone, unfortunately I am not able to speak on the phone today but I am able to grab 2 minutes here and there to add to an email conversation, I hope we can do that.

Though I have many concerns, my biggest concern is what appears to be a void in the analysis of the SEIR regarding a new road being constructed through the East portion of the reservoir on the City College and a new intersection with a left turn into the reservoir appearing on Frida Kahlo in a spot where large groups of students navigate the area at the same time before and after class.

This new road location, and essentially a new city road we're not studied in the SEIR but there are at least 11 detailed diagrams in the project Design Guidelines submitted in the SUD agenda item.

While it is to late to make public comment on the SEIR, it seems this is a very large change element to simply omit from the CEQA process and is what appears to be happening here.
