OK, the proposal is the one on the left in the attached. In the past, we've heard from SFFD that a 2' wide island would allow outriggers to be deployed over them, so we keep the island on the right side of the street at that width. We would rather have protected bikeways than the regular bike lanes shown on the right, as those have the usual problems (double parking, doors opening into them, people driving across them to get to/from parking).
