Mike,

The Street widths are the same sections which we presented at the Balboa Reservoir infra-structure meeting. They will all have the 26' clear drive for the FD access. I will bring an additional copy of those plans.

We have not yet located any of the Public Street Fire Hydrants. We assume we will be locating them in the coming weeks.

The primary issues we would like to address are the overall access to the buildings and appropriate site coverage. Our desire is not to have fire truck access into eh park/open space(s) to the greatest extent possible. Each building has atleast two sides along streets with the 26' width clearance. This was the "rule" which we had previously discussed with Lieutenant Fedigan (Ketty) on the Sunnydale development and others.

The FDC are located where ever our 150' hose lengths cannot cover the remaining facades of the buildings. This is similar to the discussion we had two weeks ago on the Sunnydale access and coverage to the rear of those buildings using FDCs.

Looking forward to meeting tomorrow morning to discuss these issues.
