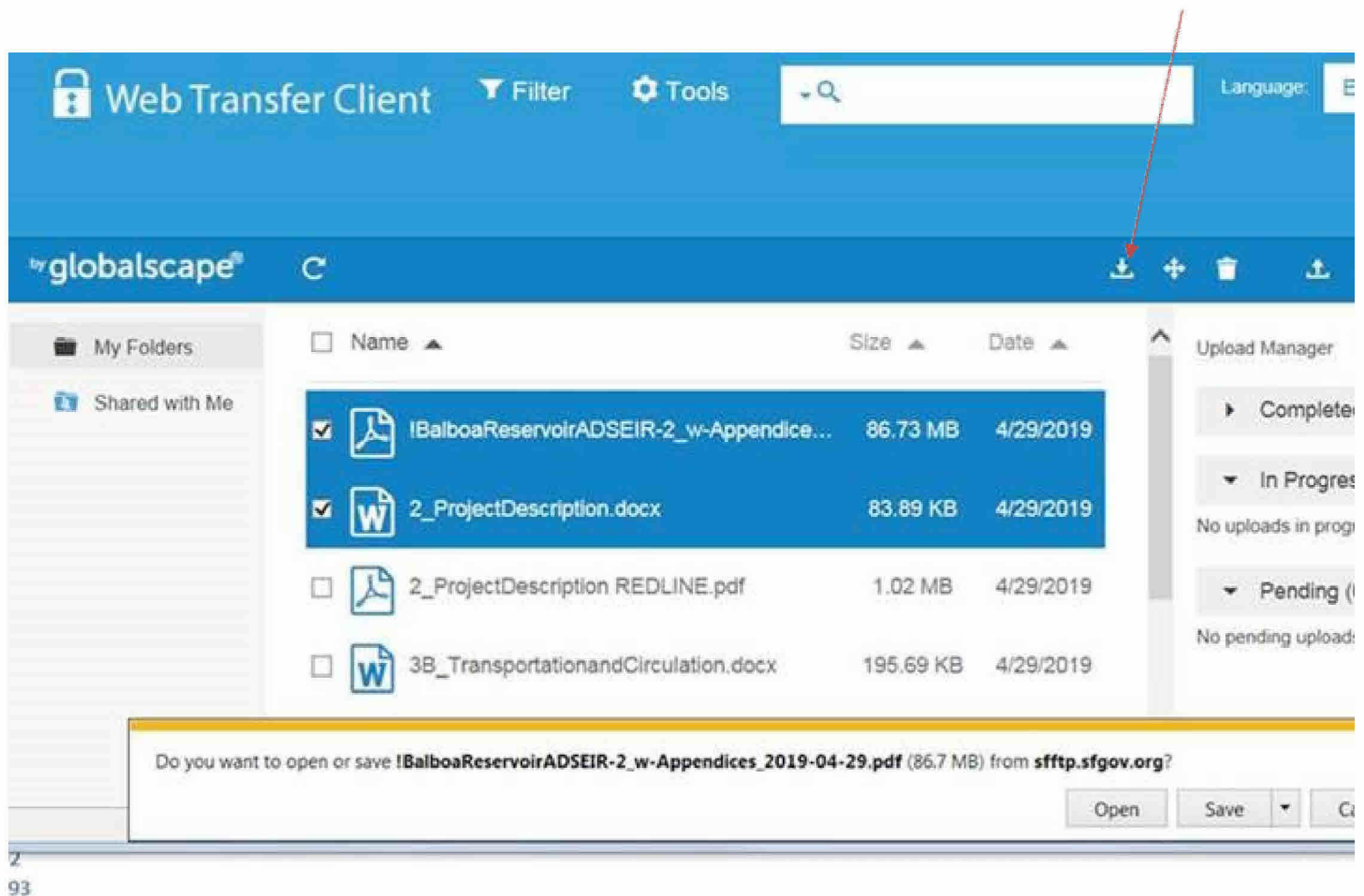

Please provide your agency's input on the project description and anything relevant to your agency's jurisdiction by **May 17**. (SFPUC, I understand you require four weeks for review; please provide your combined comments by **May 28**). Please distribute as appropriate to others in your agency and reconcile and submit all comments from your agency in one document/submittal to me by the deadline.

For those of you who provided input on an earlier draft (all but DPW), you may check the pdf tracked changes versions to see that your comments were adequately addressed. Since the last draft, there have been some revisions to the project description (see discussion of Lee Avenue near Ocean Avenue).

Also, a reminder about upcoming AB900 data transmission deadlines:

June 12 – data transmittal to city attorneys for period between 6/1/18 and 6/11/19.

July 10 – second data transmittal to city attorneys for period between 6/12/19 and 7/10/19. Staff to begin complying with post-DEIR release procedures (i.e., all correspondence must cc a dedicated email address that city attorneys will review and will be posted weekly – further information on this process will be forthcoming)

EIR schedule:

July 24 – publish draft EIR/IS

Aug 29 – draft EIR public hearing at the Planning Commission

March 12, 2020 – publish responses to comments document

March 26, 2020 – EIR certification and project approvals hearing at Planning Commission
