Mari,

Quick update on this. We've looked through the files, compared the supply to the occupancy data, and did some spot checks using Google Maps and found that the parking census data regularly undercounts the number of spaces available. Even marked/metered spaces on Ocean Ave are 3-4 spaces short on most blocks.

We are figuring out a workaround for our analysis but I wanted to bring this to your attention so you're aware of the discrepancy.

Unfortunately the SFPark.org website is down and I can't access the site you sent over. Are you able to send a GIS file or spreadsheet of the data?

My recollection from looking at a PDF map of this data previously was that it showed individual gray circles for metered parking spots and larger pink bubbles (size corresponding to capacity range) for off-street facilities. I may be mistaken but I don't recall seeing parking supply by block face on these maps, nor any count of unmarked (or unmetered) parking spaces.
