We're still confirming the exact CEQA schedule and so we don't yet know whether this will be a conflict. To your point, however, it would make more sense to move the meeting later by a week to September 16<sup>th</sup> if we needed to. I also want to make sure folks are aware that the CAC meeting is not an official CEQA forum, so comments made at the CAC will not be included in the CEQA document regardless of whether it overlaps with the comment period. We simply thought it was confusing to have the meeting and the deadline so close together.

In any event, I will update you tomorrow at 11am once I get the final schedule. That is also the reason why I am delayed in sending you advance materials for Monday's meeting – sorry about that. You'll have everything at noon tomorrow.

Thanks Jon. I am happy to discuss the DEIR comment period further.
