Rosanna,

We had not previously considered. However, I think it would be imperative to require the Developer or other City agency (who wants to use the space for other activities) to pay for the condition assessment.

This will help us determine:

- a. Risk of catastrophic failure, resulting in risk of harm to pedestrians and property damage
- b. Expected timeline for replacement project (Urgent in next 5 years vs. 20 yrs vs. 40 yrs)

This is an extremely critical pipeline that provides daily water service to about 20% of San Francisco. This pipeline also serves as a back-up (and high capacity) pipeline to pump water from UMound Reservoir to the higher Sunset Reservoir, which is a critical transfer operation following a water outage event.

We wish to carefully monitor any proposed uses of the ROW.

Hi Rosanna,

I spoke to Katie about this today and the new cross town pipeline is not currently in our 10 yr CIP but one of the existing 36" pipes in the SFPUC ROW is from 1936 and will probably be replaced in the next 15-20 yrs with a new pipeline within the ROW. If SFPUC intends to allow any planned use of the ROW for open space development, we would require a condition assessment of the existing pipelines including pothole and locate the alignment of existing pipes, material testing of pipe coupons, pipe thickness measurements, and exposing pipe joint for inspection.
