Hi Chris,

I reviewed the submittals for the Balboa Reservoir WSA request and have the following comments:

- 1. "Graywater" vs "greywater" is used interchangeably. Please select one and apply throughout the memo for consistency.
- 2. Is there any water use associated with the 231,000-339,900 gsf of parking use, such as washdown? If so, please include that demand in the calculators and memo, and briefly describe how that water use is estimated.
- 3. Page 3, last paragraph states that "19.29 to 27.18 million gpy of rainwater" is available to offset project water demand. Nowhere else in the memo nor the calculators indicate that rainwater will be used. Please confirm that

rainwater will not be used for either option and remove this reference, or else include rainwater in the rest of the memo and calculators.

4. The greywater estimates shown in Table 6 reflect supplies available, not supplies that would actually be used, as shown in Table 7. The quantity of greywater supplies available is not relevant for the WSA. I suggest updating Table 6 to reflect greywater that would actually be used (to match Table 7). If not, the WSA will still draw upon the numbers in Table 7.

Please send me the revised submittals by COB Tuesday 4/30 (1 week from today) in order to stay on schedule for the 5/28 Commission meeting. Feel free to schedule a call with me and the project sponsor to expedite responses, if needed. Thanks!
