These comments are minimal since we've already reviewed the previous iteration of the Initial Study, and it appears that our comments on that Initial Study have been addressed.

I have asked Taylor to review some language related to the project's non-potable water scheme. If she has any concerns with the language, then I will incorporate them into the comment log. I just wanted to get the rest of my comments to you ASAP.

I also have a question about the project approvals list in the Chapter 2 Project Description. I didn't think this question was appropriate to submit in the comment log, so I'm asking separately. Do you, perhaps Molly, know why the SFPUC approvals was distilled down to just one bullet point: "Actions and approvals related to a development agreement and a purchase and sale agreement, and other actions and approvals related to its jurisdictional authority"? The redline version shows a much longer list that included our various water resources-related requirements. I'm curious as to why those were struck out.
