- 2. AB 900
  - Sponsor team is still evaluating and discussing internally.
  - AB 900 requires a significant administrative effort. EP and ESA need to get set up for it and will need to look at whether it affects schedule.
  - Sponsor team agreed to provide their decision by the end of September.
- 3. Variants
  - Cost/timing of analyzing 1100 and 1300 dwelling units
    - Team agreed that the analysis of 1,100 and 1,550 units would cover the ranges discussed (i.e., 1,300 units); however, if there are impacts from 1,100 units, 800 units will be considered in the EIR *as an alternative*.
    - Sponsor team agreed to combining two of the variants: South Street shifted further south, and the parking garage on the north end of the site.
