3. Other measures not included in the City's TDM Program Standards Appendix A that the agencies agree are likely to reduce transit travel times. These measures may include off-site capital improvements, such as turn pockets, bus bulbs, queue jumps, turn restrictions, and boarding islands, and/or transit signal priority projects. The project sponsor shall pay their fair share, calculated as the project's percent contribution to the increase in travel time between baseline and cumulative conditions, of the selected measures.
