Hi Rosanna,

We will be publishing the draft supplemental environmental impact report on August 7. We're required to post a notice of availability on and around the project site. We plan to post three 24 x 36 notices: one on the fence at the dead end of Lee Ave near Whole Foods, one on the fence at the dead end of San Ramon Way in Westwood Park, and one at the northeast corner of the project site, at the intersection of north access road and the road that divides the two basins (see attached). This latter site will require that two 2" x 2" wood posts be staked about 12" into the ground to hold up the poster (the top of which needs to be 5-7 feet above grade and visible from a public street or sidewalk).

Please let me know if the PUC is OK with the digging and sign placement. The signs will be removed and stake holes filled back in after the close of the comment period (Sept 23).
