Hi Jon,

The purpose of the annual report is to keep the Board and the Mayor (it is submitted to her too) apprised of the Committee's activities and recommendations over the past year. It is not meant to make a resolution on the merits of the project, rather it is a status update. I agree that the members should collaborate on crafting the content of the report. It makes sense to me to discuss it on 9/30 and then decide whether one subsequent meeting in December is suitable. Please remember that the City will review the draft report for accuracy prior to both public meetings.

The Committee will continue to meet regularly until the project is approved by the Board and Mayor in later 2020, so there will certainly be opportunities for the Committee to weigh in separate from and subsequent to this report. In the coming months we can discuss whether there may be resolutions that the Committee would vote on related to aspects of the project or the project itself, etc. once we have more final details about the project.
