I agree – the various City codes and policies can certainly be confusing. I double-checked with the City Attorney in order to answer your question. My original response was correct in that the BRCAC is a non-Charter advisory policy body and is not required to keep minutes or audio recordings. We are encouraged to keep minutes and have done so, in addition to audio recording all but the first meeting. If you'd like a City policy reference, the City Attorney suggested looking at the Good Government Guide (<u>https://www.sfcityattorney.org/wp-content/uploads/2019/02/Good-Government-Guide-February-2019.pdf</u>) pages 157 (bottom) to 160.
